THAT By-law No. 2015-4 of the Municipality of Rhineland BE AND THE SAME IS HEREBY AMENDED to provide that borrowing in the amount of \$500,000.00 be issued to cover the costs of works completed thereunder; such borrowing to be dated the 20th day of April, 2016, to bear interest at the rate of 3.19% per annum, payable annually during their currency; and to mature in accordance with the maturities set out in Schedule "A" hereto on the 31st day of December in each of the years 2016 to 2025, both inclusive.
- 2. THAT the issue of said borrowing provides financing for all costs of works completed under authority of By-law No. 2015-4.
